INITIAL EACH ITEM

- ____ 1) I have read the Coralville Urban Chicken Ordinance and understand the requirements for keeping chickens.
- ____ 2) I am aware that I am responsible for keeping chickens within the confines of my property at all times.
- ____ 3) I am aware that I must receive approval from the City prior to obtaining chickens.
- ____ 4) I will follow all City ordinances and state laws relating to the care and keeping of animals.
- ____ 5) I acknowledge that I live in a single family dwelling located on a lot zoned for residential use.
- ____ 6) I understand that the permit is a limited license for activity and no vested zoning rights arise from the permit being issued and that the permit does not run with the property.
- ____ 7) I understand that any private restrictions on the use of the property shall remain enforceable and shall supersede the permit.
- ____ 8) I grant the right for City staff to inspect my property prior to approval of this permit and at any time to investigate a complaint.
- ____ 9) I have successfully completed the required urban chicken training and attached a copy of the certificate.
- ____ 10) I acknowledge that all chickens must be banded in accordance with procedures established by the City.
- ____ 11) I understand only hens are allowed and not more than six (6) licensed chickens are permitted per property.
- ____ 12) I understand this permit is only valid for a period of one calendar year and shall expire December 31st of each year.
- ____ 13) I understand that all chickens shall be secured in a coop from dusk to dawn.
- ____ 14) I understand City ordinance requires certain construction materials and minimum requirements for the coop enclosure.

I affirm that all statements contained in the application are true and correct and that I the permit holder will keep the chickens in compliance with all related ordinances and Urban Chicken Policy. I understand that failure to comply with regulations may result in revocation of the permit and/or issuance of a municipal infraction.
